Board Business Meeting

- Roll Call
- Consent Agenda Vote Needed
 - o Motion to approve: Spencer, Second: Ken | Motion carried unanimously, agenda approved

New Business

- Welcome Elected Officials
 - Carl Voss (City Council At-Large Member)
 - March 19th special election to replace Connie Boesen (because she was elected mayor). It's likely not to be a huge turnout, so please do come! It's the only thing that will be on the ballot. It's a city-wide At-Large seat, meaning the seat represents the whole city, not just one of the four wards.
 - The final filing day to be on the ballot is February 26th, Feb 27th will have mail-in ballots going out and you can start voting in-person Feb 28th.
 - Feb 22nd: is an all-day budget work session for the Des Moines City Council for FY 24-25. It's going to be a challenge to write a budget while the legislature is still in session.
 - Josh Mandelbaum (City Council Member for part of the Drake Neighborhood) Here to talk about our transit system. A lot of conversation is happening now about the future of DART and how we fund public transit:
 - We are talking now about how (and whether or not) we maintain our current level of public transit.

- Part of why we are here is in part due to our funding formula with other communities.
 Other communities feel like they are subsidizing Des Moines service (where the bulk of the service takes place).
- Some unexpected things affecting DART funding:
 - Privatization of Medicaid has affected DART because they were previously paying paratransit and are no longer doing that.
 - Pandemic
 - Tax rollbacks
- The legislature gave us a local option franchise fee to be used towards transit service.

 This is not the most effective tool. The hotel motel local option could have been a little more effective.
 - Best way forward as of now: implement the 2.5% (2.5 cents on utility bills)
 franchise fee to maintain as much of the current service as possible. Under
 current projections that could help maintain this level into the future (and have
 a small reserve ready for when the Reimagine DART survey is complete).
- Reimagine DART study is happening now: comprehensive transit survey
- We have a spoke-and-hub system now. Having cross-town routes takes a long time to have an effect and have people pick up on.
- There will be more opportunities for the public to provide comments later on to the DART commission.
- DART All-Access partnership exists: some landlords and some employers provide bussing
- 57% of DART riders use it to get to work. 43% of DART riders come from a household earning \$20,000 or less. 85% of riders come from a household earning \$50,000 or less. State Fair access: 240,000 rides over those 10 days. Des Moines Public Schools require transportation for anyone 3+ miles from the school and they use that. Teachers also use it from the All-Access pass.
 - \$1.1 million from the schools for All-Access. Saves the school money and is good DART money.
- "I think we should maintain as much of the transit service as possible as we have today."

- City SCRUB days are coming up, all dates, times and locations are in an addendum below.
 - They can use some volunteers for these days
- Sadie Trytten Neighborhood Development Corporation: Present the drawings for the 2211 University Ave site (former Kum & Go) + the architect is here, too
 - UA Station: Some things have changed: there was going to be a grocery store but they are not going to move anymore. There will be now work/live space.
 - 2 bed, 1 bed and studio. 34 total units, 12 units on top, 12 on middle and then 10 on the ground floor – 6 are work/live 4 are studio. Gym. Elevator access. 1 parking spot per tenant. Parking is 47% of the project.
 - 60% of the units are market rate. \$800-\$1,700 for rent.
 - 500 sqft for smallest studios.
 - The live/work will rely on some of the street parking for their customers.
 - O How much workforce housing is needed for the city? Connie, Josh and Carl all weighed in
 - From the Workforce Development Survey: The goal is 60,000 new units in 2040, bulk of them being workforce/market rate

- When the city aims for more density but we already struggle with parking, we need to understand a little more about how we fit into the overall picture
 - Being right off 31st or University are a little more dense
 - Could be try to step density down step-wise with townhomes or other middle-density living
- Jeff Wiggins City of Des Moines Forest Avenue Project Overview and Comment Period
 - Here to talk about a project on 23rd Street traffic study addenda below
 - No major crash info "to write home about"
 - No major issues calling out here the transformation would be pretty simple
 - Proposed 4 speed humps between Washington and Lincoln
 - For a 6 mph reduction, getting us to the 25 mph average
 - The distance of 400' keeps people going slow. 600' gap people speed up every time
 - This all started from a petition from a neighbor in the corridor. 85%-90% are started by Council Members on behalf of people. This is one of the rare ones where the person petitioned and got 60% of the property owners or residents in the area to sign + need to have at least 500 vehicles per day at least to qualify.
